Flights will be determined by World Ranking, with 24 players in Championship Flight and 16 players in First Flight. Players with a World Ranking grade of 2000 or higher (and unranked players with a USCA handicap of 2 or lower) are not eligible for First Flight. Players with a grade below 2000 may request to play in Championship Flight; final decision on flights will be made by the Tournament Director. Additional flights may be added at the discretion of the TD based on the number of entrants.

Player discounts of 50% are available to full time students (25 yrs old or younger) for this USCA tournament. Proof of student status required.
